Tests for COVID-19: What do you need? What are you able to get?

Even for those who feel relatively safe, the COVID-19 coronavirus pandemic remains a wet blanket over our everyday actions, over our economy, and over our lives.

And according to the Johns Hopkins University COVID-19 "dashboard," as of this writing (late January 2022), over 866,000 deaths in the United States have been attributed to COVID-19. (coronavirus.jhu.edu)

The Paralyzed Veterans of America exists solely to improve the quality of life of paralyzed veterans, so along those lines, the Keystone Chapter would like to know if we can provide our members with assistance in obtaining COVID-19 tests.

By the time you receive this, the federal government's program to send four test kits to each household that requests them will be underway (COVIDtests.gov). But is that enough?

There's a lot to be said for continuing to wear masks when in indoor congregant spaces (grocery and retail stores, for example) or riding with others in private or public vehicles; for distancing (especially staying out of crowds), and for lots of handwashing and hand sanitizing.

But no matter how confident you may feel about your own

Pandemic update: office visit guidelines

Limited visitation to the chapter office is now permissible by fully vaccinated members and with advanced notice. Those visits should be brief and business only. Unannounced/unvaccinated visitors will be met in the parking lot. If a visit does not have to be made in person, please use email, phone, or arrange for a Zoom call.

What members need to know about travel reimbursement

Generally, there are two categories of reimbursement that the chapter makes to its members: **Business** reimbursements and **recreation** reimbursements.

A member who engages in a preapproved activity on behalf of the chapter, such as visiting a VA medical center to attend a VA voluntary services meeting, is engaged in a "business" activity. That travel is eligible for reimbursement at a rate set periodically by the Board of Directors.

A member who participates in an optional, personal recreational activity, such as hunting, bowling, or attending a sporting event, is engaged in a "**recreation**" activity.

Mileage reimbursement requests for recreation activities will only be approved if the travel reimbursement was approved in advance of the event by the chapter Board of Directors. Two examples: Travel to the bowling alley to bowl will not be reimbursed. But the sponsorship for attending the National Veterans Wheelchair Games specifically includes reimbursement for travel (or, in the case of the Games, air travel may be paid in advance by the chapter).

<u>All reimbursement requests should be made at one time each month,</u> prior to the 7th of the month, using the chapter's Volunteer Expense Report, which may be requested from the office in electronic or paper form. Completed forms can be returned the same ways.

A member should NEVER assume that any reimbursement is guaranteed. None are guaranteed, and all reimbursements must be approved by the Board of Directors.

At this time, the rules for reimbursement in the chapter's Operations Manual are being revised for clarity, consistency, and as much specificity as possible. Thanks to members for your understanding and patience.

health, you probably don't want to risk carrying the virus where it may be transmitted to other more vulnerable individuals. That's when a test kit may come in handy to assure yourself and others that you are not a virus carrier.

So, to help the chapter figure out if we might be able to help you obtain COVID-19 test kits, we have three questions:

- 1) If you had easy access to COVID-19 test kits, would you use them? (Probable responses: yes or no)
- 2) Are you comfortable ordering test kits online?

(Probable responses: yes, no, or I don't use a computer or "smart" phone)

3) If you do want test kits and can order them, and the four kits you can get free from the federal government aren't enough, would you like to be reimbursed for any costs of extra kits?

(Probable responses: yes, yes if they cost a lot, or no)

You can call us (412-781-2474 or 800-775-9323) or send us an e-mail to tell us what you think. We will send this same message to members by e-mail, for your convenience.

The information you give us will help determine next steps—thanks!



MEMBERSHIP PROGRAMS

- ► All receipts submitted for reimbursement must be dated within the Chapter's current fiscal year, 01 October—30 September.
- ► Keystone PVA will reimburse voting members for their annual resident hunting license, with a limit of one (1) Antlerless Deer License annually. Member must send a copy of all licenses and a receipt to obtain reimbursement. The cost of a resident fishing license will be reimbursed. Members may also be reimbursed for their membership dues for sports club memberships.
- Social Activity Reimbursement: Keystone PVA will reimburse voting members* up to \$100.00 one time during a fiscal year for the expenses of attending a social activity of these types:
 - Dinner at a sit-down restaurant Movie theater, live theater, concert, or sporting performance Museum, zoo, amusement park or cultural/historic attraction.

Member must send request for reimbursement, with receipts, within 30 days of the event to the chapter office including a short description of the outing. If convenient, send a photo of the event, with a complete description, by e-mail to the office for its use in promotion of the chapter's programs.

*This benefit is intended for the use of life members who do not and will not participate in any other sponsored or reimbursed sports and recreation activities paid for by the chapter except for the Kennywood Park Picnic and Annual Awards Banquet. Should a member use this benefit and then claim reimbursement for another activity paid for by the chapter other than the picnic or dinner, the chapter may request repayment of the Social Activity Reimbursement.

- The Chapter currently has a weekly bowling league available to members as a recreational activity and to practice for the National Veterans Wheelchair Games (NVWG). Scores are in the newsletter and awards will be presented at the Chapter annual banquet. The Chapter may also reimburse members for other activities offered at the NVWG such as trapshooting and archery.
- Reimbursement for hunting, trapshooting and fishing programs that Keystone PVA supports or sponsors.
- ► Members that accumulate 12 points or more by attending membership meetings, attending Chapter functions, volunteering at VA medical centers, etc., qualify to participate in the Keystone PVA Sports and Recreation Program.
- All program expenses must be approved by the Keystone PVA Board of Directors.

Keystone Chapter Health and Recreation Points System

To be eligible for chapter sponsorship to the National Veterans Wheelchair Games and other recreational programs, a member may earn points by participating in these activities. Sponsorship by the chapter requires 12 points per EACH event.

- Members are required to attend at least one Membership Meeting prior to attending a sponsored event.
- To receive credit for mileage, volunteer time & points, member MUST forward a Time Sheet—Volunteer Program Report (formerly titled the "Keystone PVA Volunteer Expense Voucher") and an After Action Report to the chapter office by the close of business on the 7th day of the following month. If the office is closed on the 7th, expense vouchers are due by the close of business the next working day.
- ► All volunteers at the VA Medical Centers must complete volunteer training and receive a volunteer ID card. The volunteer hours MUST be in the name of PVA. Volunteer is responsible for forwarding the monthly VA Volunteer by Organization Report (VS26) to the chapter office by the end of the following month to receive travel expenses.

More comprehensive information on chapter programs is in the chapter's Operations Manual Section 8. A copy was sent to each member some time ago; parts of it have been updated, so if you need a copy, please call the office.

MEMBERSHIP ELIGIBILITY

Lifetime membership is **free** and there are **no dues required** for qualified **veterans** who apply to the Chapter for membership.

Our newsletter no longer includes a membership application, but online application can be made at the national PVA web site, **pva.org**. For help, call the office, 412-781-2474 or 800-775-9323.

Life membership in the PVA is available to any U.S. citizen who served on **active duty** in the Armed Forces of the United States and who sustained **spinal cord dysfunction** because of traumatic injury or disease. Separation from military service must have been under other than dishonorable conditions.

The Life Member receives all benefits according to the Bylaws of the Chapter of record and has equal voting rights with the other members. The Life Member is also entitled to attend Chapter meetings, hold office at the Chapter and National levels and receive PN Magazine, chapter publications and bulletins from the National Office. In order to hold office, however, the Life Member must receive certification from PVA's National Secretary.

President's Report for Fiscal Year 2021 . . . Mark Rosensteel

Immediately before and after this specific period of time, we lost valued Board members and past presidents Jerry "Bull" Baylor (August 2020) and James Riemer (October 2021). Jim was my immediate predecessor as chapter president, but he held several other important posts over his 28 years of membership, including treasurer and national director. Jim was quiet, but his actions spoke of his commitment to the National Veterans Wheelchair Games, and his integrity as he helped the chapter navigate from near insolvency to relative financial comfort, and through financial challenges that have resulted in conservative but productive investments.

Two new Board members, Sean Ferry and Joe Dunn, are welcome additions under the sad occasions of Bull's and Jim's departures.

Due to the restrictions from the COVID-19 our volunteer members have not been able to visit our fellow veterans as they normally would. But in some of the VA hospitals some activities are still available to the veterans with some modifications, and we are providing support for them. Activities such as bingo games and pizza parties are still being maintained in the Erie, Altoona and Lebanon VA medical centers.

Fortunately we were still able to hold some outdoor events. Our annual Kennywood Park picnic had a decent turnout of members, families and caregivers. We were also able to hold the annual Bass Tournament with the usual disabled anglers and boat captains. I enjoyed it enormously and during the tournament I discussed having two fishing events a year with Greene County BassMasters

President Larry Freeman, who arranges for the bass boats and captains. We agreed to have two Bass Tournaments in 2022.

For the second year we were unable to hold our Annual Awards Banquet in person, but we did the next best thing, which was to hold it virtually. Door prize tickets were drawn to give away gift cards to those who attended, and those who attended were provided gift cards to have dinner at a restaurant of their choice. My hope is that by October 2022 we will hold the annual banquet in person.

Keystone PVA's mission is not only to provide activity and benefits to our members, but to also keep a watchful eye on the health care our veterans receive, frequently from the VA at VA medical centers. When we become aware of any factor, issue or event that might jeopardize the care our paralyzed veterans might get, we endeavor to work with all parties involved to reach a resolution. Obviously, no one speaks for paralyzed veterans as well as we do, but the consequences of our work goes far beyond our membership, improving care for non-paralyzed veterans and even paralyzed civilians.

As most of you know we have been holding our bi-monthly Membership Meetings via Zoom videoconferencing, which has allowed people with Internet access to attend from greater distances than was true before. We have held so many routine meetings of the chapter—Board of Directors meetings, for example—via videoconference that we have equipped our chapter's conference room with a large screen and high-definition camera. We expect to use this means of meeting in conjunction with in-person get-togethers even after the pandemic eases—"hybrid" meetings.

Demonstrable financial integrity is essential for a nonprofit organization. When the office was restaffed in August, one of the new employees—actually a contract worker, Nancy

Campbell—was an experienced accountant, familiar with the recording and reporting needs of a smaller organization. Also hired was Marisa Markowitz, who is learning how to manage membership and projects. Both of them are part of the financial management structure, which makes five people total involved in the chapter's everyday financial activity.

During FY 2021, Joe Dornbrock remained the chapter executive director. He has been on the job for us since 2005, and continued to work with other PVA chapters as the treasurer for the Association of Chapter Executive Directors and the Association of Chapter Government Relations Directors.

Membership

Military veterans who have a spinal cord injury or spinal cord disease, and who were discharged under other than dishonorable conditions are welcome to join the Paralyzed Veterans of America free of charge.

At the end of FY2021, the Keystone chapter had 232 life members, 126 with service connected spinal cord dysfunctions and 106 non-service connected.

It is important for current members to keep the chapter informed of changes to addresses, e-mail addresses, and phone numbers to keep in touch. And, as always, Keystone PVA's membership lists will not be shared outside the PVA. **This chapter will not sell membership lists.**

Keystone PVA also offers associate memberships to individuals who do not have a spinal cord injury or disease. The dues for associate membership are \$25.00 per year. Lifetime associate membership is available for a one-time fee of \$250.00.

Over 800 donation boxes are located all over the Pittsburgh Region!

American Thrift Center manages and collects the contents of the boxes, and operates a thrift store in West Mifflin, Pa. It is registered as a fundraising organization with the Commonwealth of Pennsylvania. Its only beneficiaries are the Keystone Paralyzed Veterans.
