

You can contribute to SCI research

As the Keystone Chapter's Advocacy Director, I am pleased to let you know about new advocacy and educational opportunities available to you as a Keystone PVA member.

In October 2023, Cheryl Vines, Director of Research and Education at PVA National and Lisa Elijah, PVA's Grassroots Advocacy Manager, published a webinar entitled "Research is the Foundation of Successful Advocacy." The webinar is available to view on PVA's website at **pva.org./research-resources/disability-rights-advocacy/webinars/**.

During the webinar, we are introduced to the North American Spinal Cord Injury Consortium and a new educational program, the NASCIC "SCI Research Advocacy Course." The course is comprised of 12 modules, covering a range of topics including research advocacy, SCI biology, neuroprotection, neuroplasticity, and many others. The course takes approximately six hours to complete and can be found on the NASCIC website: **nascic.org**.

The purpose of the course is to familiarize you with the issues that SCI research is addressing, and to better prepare you if you wish to participate in that research.

The course is available to you, your caregivers, and other interested individuals free of charge. You can register using the information on the next page.

National Director's Report Bill Jakovac

The national Paralyzed Veterans of America's Fall Board of Directors meeting was held in Orlando, Florida, from 21 to 23 October 2023. I participated as the Keystone Chapter's elected director; Chapter Executive Director Joseph Dornbrock also attended.

All 33 chapters were present, though two chapters were not able to vote. After the national PVA officers submitted their reports, the floor was opened for questions from the directors.

I had questions concerning the recently established Multiple Sclerosis Committee's funding and activities. Ken Ness, the MS Committee vice chair and our chapter's liaison vice president said that the request of funding for activities was not mandatory and was for the purchase and distribution of MS T-shirts and the like.

Hannah Buchholz, Director Meetings Services, gave a detailed presentation on PVA meetings, site selection, and the costs of having meetings. We learned that meeting sites must meet certain requirements, such as accessibility, elevators with easy access and numbers, sleeping rooms/accommodations, and meeting rooms for all activities. Other considerations for sites include airport access and prices of rooms, travel, and food. Among the number of sites presented, Orlando scored high in all categories of being cheapest in cost, air travel, and accommodations. The gist of this presentation was meetings are expensive and we should strive to save where we can. At this time, there was a motion made for meeting services to consider the feasibility of having one site to hold all meetings. This motion was approved.

The second main presentation was training on sexual harassment prevention. This involved several office scenarios followed by discussions on what behaviors and such were shown.



The athlete is responsible for completing the application form and following its instructions. The deadline for National PVA to receive your application is expected to be on or around 15 April 2024.

All members, life and associate, planning to attend the 2024 National Veterans Wheelchair Games in New Orleans, Louisiana, and who want the chapter to pay for transportation and lodging must submit **both pages of this chapter sponsorship form** to Keystone PVA, 1113 Main Street, Pittsburgh PA 15215.

ALL **SPONSORSHIP FORMS** MUST BE POSTMARKED NO LATER THAN **31 DECEMBER** <u>2023</u>. THERE WILL BE NO EXCEPTIONS.

- Due to the inability of our members to earn sufficient Health and Recreation Points during the pandemic, these "points" will not be required for sponsorship eligibility in the chapter's fiscal year 2024 (Oct. 1 to 30 Sep.).
- Circumstances, including the manner in which the Games are held, may change with little notice.
- •Keystone PVA funds are limited, so the amount of chapter funding for each participant may depend on the total number of applicants and the budget limits set by Keystone PVA's Board of Directors.

I understand that in participating in the NVWG, Keystone PVA will pay for lodging and transportation as follows: LODGING: No more than seven nights of single-room lodging per Life Member. Lodging expenses are limited to the room rental rate, directly associated taxes and fees, and any portage fees that may be imposed by the hotel. TRANSPORTATION: Chapter will reimburse each Life Member at a per-mile rate to be determined by the Board of Directors for direct, round-trip transportation from the Life Member's home to the airport from which the member is departing to attend the Games; parking at the airport capped at the reduced rate offered for adapted vehicles; and will pay for up to two round-trip air fares at the most economic available rates from the airport providing appropriate service nearest the member's home to Louis Armstrong New Orleans International Airport, Jefferson Parish, Louisiana. Member is responsible for arranging for transportation from Louis Armstrong New Orleans International Airport to lodging in New Orleans, Louisiana.

Train with electromyography (EMG) wristband for precise hand control in immersive tasks through the use of virtual reality (VR) despite hand paralysis







You May Qualify If You

- Are 18+ years or older with spinal cord injury (3+ months post-injury)
- Have impaired wrist/finger movement.
- Are comfortable with wearing VR headset and EMG wristband.
- Can look at a screen for more than an hour.

Potential Benefits

Participation in this study may help you learn EMG control for gaming and occupational tasks in an immersive setting, with potential therapeutic benefits.

Participation Involves

- Calibration experiments to isolate EMG activity and training to master EMG timing and intensity control.
- Utilizing a head-mounted display for immersive occupational virtual tasks
- One or more testing visits per week for up to six months

Keystone Chapter Health and Recreation Points System

•Members are required to attend at least one Membership Meeting prior to attending a sponsored event.

- To receive credit for mileage, volunteer time & points, member MUST forward a Time Sheet—Volunteer Program Report (formerly titled the "Keystone PVA Volunteer Expense Voucher") and an After Action Report to the chapter office by the close of business on the 7th day of the following month. If the office is closed on the 7th, expense vouchers are due by the close of business the next working day.
- All volunteers at the VA Medical Centers must complete volunteer training and receive a volunteer ID card. The volunteer hours MUST be in the name of PVA. Volunteer is responsible for forwarding the monthly VA Volunteer by Organization Report (VS26) to the chapter office by the end of the following month to receive travel expenses.

For more information on chapter programs, refer to Operations Manual Section 8, which you may request from the chapter office.

MEMBERSHIP PROGRAMS

- ← All receipts submitted for reimbursement must be dated within the Chapter's current fiscal year, 01 October-30 September.
- The Chapter has an annual picnic at Kennywood Amusement Park and an Annual Awards Banquet.
- Keystone PVA will reimburse voting members for their annual resident hunting license, with a limit of one (1) Antlerless Deer License annually. Member must send a copy of all licenses and a receipt to obtain reimbursement. The cost of a resident fishing license will be reimbursed. Members may also be reimbursed for their membership dues for sports club memberships.
- Member Recreation Reimbursement Fund. Keystone PVA will reimburse voting members up to \$100 for attending any recreational event one time during the fiscal year or until the fund is depleted. Member must send receipts within 30 days of the event to the chapter office including a short description of the outing; good photos appreciated. This benefit is intended for members who do not take advantage of reimbursements and chapter payments for hunting and fishing licenses, or participation in recreational programs such as the National Veterans Wheelchair Games.
- Fitness club membership. The Chapter will reimburse members quarterly for memberships in nonprofit or for-profit organizations such as the YMCA, YWCA, Planet Fitness or LA Fitness up to \$10 monthly or \$30 quarterly.
- Weekly bowling league available to members as a recreational activity and to practice for the National Veterans Wheelchair Games (NVWG). Scores are in the newsletter and awards will be presented at the Chapter annual banquet.
- Reimbursement for hunting, shooting and fishing programs that Keystone PVA supports or sponsors.
- (Currently, this rule remains suspended.) Members that accumulate 12 points or more by attending membership meetings, attending Chapter functions, volunteering at VA medical centers, etc., qualify to participate in the Keystone PVA Sports and Recreation Program.
- All program expenses must be approved by the Keystone PVA Board of Directors.

The third presentation was given by PVA General Counsel Len Selfon. He gave the legal aspects of everything from the Code of Ethics to the fiduciary obligations of directors. He used all the legal terms, explaining them clearly and in detail. I am now more aware of the legal aspects of my responsibilities as director.

There were seven resolutions for review and consideration:

- 23-O-1 Increase Amount of Maximum Income for BOD Representation
- Cost of Living Adjustment (COLA) primarily for Executive Committee members; passed with 29 ayes, no nays, and one abstention. 23-O-2 BOX Submission Process for Chapter Finance Reporting
- Electronic submission of annual reports instead of mailing. Passed 30-0-0.
- 23-O-3 Renaming National President's Award to Gilford Moss. This was on the Consent Agenda and was earlier approved unanimously.
- 23-O-4 (S) Investment Allocation Policy Parameters. Concerned ratios in the investment portfolio. Passed unanimously.
- 23-O-5 Chapter Program Expenditures. Concerned penalties of chapters being too successful in fundraising. This has been previously presented many times and was once more returned to committee.
- 23-O-6 Changes to the Chapter Election Process

Proposed that a chapter having an unopposed ballot can be approved by acclamation of members present at a membership meeting. I was the first director to propose defeat of this resolution. I pointed out that it did not involve all members of the chapter and voided the right of a member to write in a candidate. Many joined me and the resolution was withdrawn.

23-0-7 Membership and Transfer Application Changes

Added some questions on Veterans Status Information. The motion to send it back to committee was approved 24-6-0.

Final thoughts from the meeting on cutting future costs:

Last year, there was a resolution to reduce the lengths of the Fall BOD meeting and the Annual Convention by a day. The BOD disapproved it. There will be a future resolution and it will more likely be approved.

Meeting sites around the country are currently held near chapters' cities. This is a good thing. If meeting services finds it is cost effective to choose a permanent site for all meetings, approval of the directors may not be unanimous, but I believe it will be approved.

After the Board meeting was adjourned, chapter presidents and executive directors remained in the meeting room to continue training.
