# **Cooper receives national tech award**

Rory A. Cooper, Ph.D., director of the Human Engineering Research Laboratories in Pittsburgh, received the National Medal of Technology and Innovation for his work in rehabilitation and support for disabled people.

Dr. Cooper was cited "For empowering the lives of millions of Americans. By inventing and developing cutting-edge wheelchair technologies and mobility devices, cultivating the next generation of rehabilitation engineers, and championing wounded veterans and students with disabilities, he moves us closer to being a nation that is accessible for all."

The award was presented at the White House by President Joseph R. Biden Jr. on 24 October. Dr. Cooper was among 12 honorees in 2023.

The honor is granted by the President of the United States to American inventors and innovators who have made significant contributions to the development of new and important technology. The award was created by Congress in 1980 under the Stevenson-Wydler Technology Innovation Act.

Dr. Cooper has been a member of the Keystone Paralyzed Veterans of America since 1994 and of the Paralyzed Veterans of America since 1984.

# Volunteer from home!

Consider the Compassionate Contact Corps.

The Veterans Health Administration has established the "Compassionate Contact Corps," an outreach program in which volunteers reach out by telephone to veterans to provide conversation, companionship, support, and another link for the veteran to the health care to which he or she is entitled.

The program is in operation at two VA hospitals in Pennsylvania that we are aware of: VA Pittsburgh Healthcare System, 412-822-3084, and at the Wilkes-Barre VA Medical Center, 570-824-3521, ext. 27448.

This program gives a volunteer the opportunity to serve from home. There are no medical or home care duties associated with it, and generally asks for service one or two times a week for 15 to 60 minutes each time.

Keystone PVA will ask that, like all volunteering, that the program participant reports the hours spent so that we can keep track of this service.

The VA Voluntary Services offices at each VA medical center has other volunteer opportunities, most of them in-hospital, that anyone may also wish to consider. Keystone PVA has many volunteers, members and nonmembers, who serve at their local VA medical centers and get credit for the hours they put in. We have volunteers who have been credited with thousands of hours over the years, and many who have put in fewer. All are of value to our fellow veterans.

Team Bass Tournament co-director Tom Strang declared the Monongahela River "fished out" by the time he and his fellow anglers and boat captains cast off for the late summer tournament on 10 September at the American Legion Post 940 marina in West Brownsville. The weather delayed the start, but seven teams soon took to the Monongahela River for the second bass fishing event of the year. The tournament is co-sponsored and conducted by Keystone PVA and the Outcast Bass Club.

The biggest bass, at 2.64 lbs., was pulled in by Keystone PVA member Jorden Jones. The second biggest bass weighed 2.62 lbs. and was caught by Outcast Bass Club President Larry Freeman.

To apply to <u>participate</u> in the Games, each athlete must download the National Veterans Wheelchair Games application form, which will be available after the first of the year from <u>www.wheelchairgames.org/registration</u>. The athlete is responsible for completing the application form and following its instructions. The deadline for National PVA to receive your application is expected to be on or around 15 April 2024.

All members, life and associate, planning to attend the 2024 National Veterans Wheelchair Games in New Orleans, Louisiana, and who want the chapter to pay for transportation and lodging must submit **both pages of this chapter sponsorship form** to Keystone PVA, 1113 Main Street, Pittsburgh PA 15215.

## ALL **SPONSORSHIP FORMS** MUST BE POSTMARKED NO LATER THAN **31 DECEMBER** <u>2023</u>. THERE WILL BE NO EXCEPTIONS.

- Due to the inability of our members to earn sufficient Health and Recreation Points during the pandemic, these "points" will not be required for sponsorship eligibility in the chapter's fiscal year 2024 (Oct. 1 to 30 Sep.).
- Circumstances, including the manner in which the Games are held, may change with little notice.
- •Keystone PVA funds are limited, so the amount of chapter funding for each participant may depend on the total number of applicants and the budget limits set by Keystone PVA's Board of Directors.
- Applicants for sponsorship will be notified of the decision of the Board of approval or denial after its January 2024 meeting. Travel and lodging arrangements will be made with each athlete by Keystone PVA following approval.

Lodging expenses are limited to the room rental rate, directly associated taxes and fees, and any portage fees that may be imposed by the hotel. TRANSPORTATION: Chapter will reimburse each Life Member at a per-mile rate to be determined by the Board of Directors for direct, round-trip transportation from the Life Member's home to the airport from which the member is departing to attend the Games; parking at the airport capped at the reduced rate offered for adapted vehicles; and will pay for up to two round-trip air fares at the most economic available rates from the airport providing appropriate service nearest the member's home to Louis Armstrong New Orleans International Airport, Jefferson Parish, Louisiana. Member is responsible for arranging for transportation from Louis Armstrong New Orleans International Airport to lodging in New Orleans, Louisiana.

Keystone PVA is under no obligation to pay for any other expenses unless specifically permitted in advance by the Board of Directors. Should I become unable to participate in the NVWG because of circumstances demonstrably beyond my control (e.g., illness), I agree to notify Keystone PVA as soon as I know. Should I not notify Keystone PVA in a timely manner and Keystone PVA incurs expenses on my behalf, I will repay Keystone PVA for those expenses except when those circumstances arise within 48 hours of the start of the Games.

# Keystone Chapter Health and Recreation Points System

•Members are required to attend at least one Membership Meeting prior to attending a sponsored event.

- To receive credit for mileage, volunteer time & points, member MUST forward a Time Sheet—Volunteer Program Report (formerly titled the "Keystone PVA Volunteer Expense Voucher") and an After Action Report to the chapter office by the close of business on the 7th day of the following month. If the office is closed on the 7th, expense vouchers are due by the close of business the next working day.
- All volunteers at the VA Medical Centers must complete volunteer training and receive a volunteer ID card. The volunteer hours MUST be in the name of PVA. Volunteer is responsible for forwarding the monthly VA Volunteer by Organization Report (VS26) to the chapter office by the end of the following month to receive travel expenses.

For more information on chapter programs, refer to Operations Manual Section 8, which you may request from the chapter office.

# MEMBERSHIP PROGRAMS

- ← All receipts submitted for reimbursement must be dated within the Chapter's current fiscal year, 01 October-30 September.
- The Chapter has an annual picnic at Kennywood Amusement Park and an Annual Awards Banquet.
- Keystone PVA will reimburse voting members for their annual resident hunting license, with a limit of one (1) Antlerless Deer License annually. Member must send a copy of all licenses and a receipt to obtain reimbursement. The cost of a resident fishing license will be reimbursed. Members may also be reimbursed for their membership dues for sports club memberships.
- Member Recreation Reimbursement Fund. Keystone PVA will reimburse voting members up to \$100 for attending any recreational event one time during the fiscal year or until the fund is depleted. Member must send receipts within 30 days of the event to the chapter office including a short description of the outing; good photos appreciated. This benefit is intended for members who do not take advantage of reimbursements and chapter payments for hunting and fishing licenses, or participation in recreational programs such as the National Veterans Wheelchair Games.
- Fitness club membership. The Chapter will reimburse members quarterly for memberships in nonprofit or for-profit organizations such as the YMCA, YWCA, Planet Fitness or LA Fitness up to \$10 monthly or \$30 quarterly.
- Weekly bowling league available to members as a recreational activity and to practice for the National Veterans Wheelchair Games (NVWG). Scores are in the newsletter and awards will be presented at the Chapter annual banquet.
- Reimbursement for hunting, shooting and fishing programs that Keystone PVA supports or sponsors.
- (Currently, this rule remains suspended.) Members that accumulate 12 points or more by attending membership meetings, attending Chapter functions, volunteering at VA medical centers, etc., qualify to participate in the Keystone PVA Sports and Recreation Program.
- All program expenses must be approved by the Keystone PVA Board of Directors.
